## 2024 BREEDING CONTRACT

This certifies \_\_\_\_\_, herein referred to as "Mare Owner/Agent," has engaged one service to the stallion **THE OFFSHORE ACCOUNT, APHA #1065791, AQHA #5693782**, owned by TRUE NORTH SHOW HORSES, LLC, herein referred to as the Stallion Owner, for the Mare \_\_\_\_\_ Breed \_\_\_\_\_, Reg # \_\_\_\_\_ for the 2024 breeding season beginning February 7 and ending July 1, 2024 unless special arrangements are made in writing. Any deviation from these terms must be specified in writing and signed by the Stallion Owner or the Stallion's Owner authorized agent.

**Charges:** The Stallion Service Fee is \$1800.00 which includes a nonrefundable Booking Fee of \$500.00. The \$500.00 Booking Fee is due with signed contract. The balance of the Stallion Service Fee of \$1300.00 is due and payable at least ten (10) days prior to ordering semen.

**Stallion Service Auction (SSA) or Donated Services:** Any donated, gifted or retained breeding is subject to \$300 farm fee. List applicable Stallion Service Auction or donated program \_\_\_\_\_.

**The Mare Owner MUST provide to the Stallion Owner at time of execution of the Breeding Contract:**

1. A copy of Mare's Registration papers (front and back).
2. The Owner of record on the Registration Certificate shall be the Owner recorded on the Stallion Breeding Report. A copy of fully executed breed association Lease Authorization Form if mare is leased at time of breeding.
3. A completed signed copy of Breeding Contract and forms.
4. The applicable nonrefundable booking fee or Stud Fee.

**PAYMENT**

Payments may be made by check or by credit card. A 4% nonrefundable convenience fee will be added to all credit card payments. Mare Owner is responsible for any returned check fees or chargeback fees.

**SEMEN SHIPMENTS**

Semen orders must be made by submitting the attached **Semen Request Form** to the Stallion Owner by e-mail **the day prior to collection, no later than 6:00 pm CST**. Cancellation must be made by 8:00 am CST. on shipping day to avoid a cancellation fee. We will ship on a first requested, first served basis. Two doses of semen will be shipped if available, however on heavy collection days only one dose may be available.

1. The Stallion is collected **Mondays, Wednesdays, and Fridays**.
2. A signed contract does not guarantee semen will be available on a given day.
3. **Shipping fees are subject to change, should FedEx and/or UPS rates or Stallion Station fees increase.**
4. Shipping method is regular priority overnight, If the recipient specifically requests First Overnight, additional charges will apply.
5. The Stallion Owner, Management, and any affiliated parties will have no liability for semen once it leaves the facility, and shall not be held responsible for the costs or damages arising from shipments lost, damaged, or delayed in transit, or condition of cooled shipped semen upon delivery. No refunds or shipment credits are owed for any such instances.
6. **No shipments shall be made to any Mare Owner with an outstanding balance.** Semen will not be shipped to any mare unless a current credit card number/expiration/ccv code are provided on this contract or shipping is prepaid with check or money order. Payments for shipments are processed when the request form is received.
7. Stallion Owner reserves the right to refuse a shipment for any reason, including, but not limited to, an untimely request.
8. Stallion Owner reserves the right to require a negative uterine culture/cytology should the mare fail to settle repeatedly.
9. Mare Owner agrees that if they fail to cancel any shipment by 8:00 am CST on a collection day, a cancellation fee may be incurred
10. Shipping containers must be returned in a timely manner. If container is not returned within one week of shipment, a \$40 fee will be charged to the credit card on file.

**MARE BREEDING CONDITION:** Mare Owner represents and warrants that the Mare is in sound breeding condition and free from infection and disease. Any Mare certified by the attending veterinarian not to be, in his/her opinion, in sound breeding condition, shall not be bred. If multiple shipments are requested, Stallion Owner reserves the right to request a negative uterine culture, cytology, or biopsy prior to sending further shipments.

**COOLED SEMEN HANDLING:** Mare Owner agrees to assume responsibility for all the facets of breeding the Mare and agrees to comply with all related breed registry requirements as applicable, concerning the use and handling of cooled semen. The Mare Owner agrees that an individual who is qualified and experienced in the use and handling of cooled semen will perform the insemination. Mare Owner agrees to use all semen provided by this Agreement solely to breed the Mare named in this contract and no other.

**MULTIPLE FOALS:** This agreement provides for one foal for the 2024 breeding season from this Mare. Should more than one embryo or foal result from such breeding, the Mare Owner must notify the Stallion Owner within 48 hours of transfer of the embryo(s). If embryo transfers result in multiple pregnancies, then the Mare Owner must pay the Stallion Owner the Stallion fees for EACH pregnancy before ANY breeder's certificates are issued. Such payment shall be due within 60 days of confirmed pregnancy in order to receive a certificate for the additional foal(s).

**LIVE FOAL GUARANTEE (LFG):** Live foal means that the foal resulting from the breeding stands and nurses without assistance and lives for 24 hours. It is understood that if a Live Foal does not result from the breeding a return season will be guaranteed the following year only, provided proper notification is given. Proper notification shall be defined as follows: written certification by a licensed veterinarian within seven days that the Mare has slipped or produced a non-viable foal. Mare Owner certifies that such abortion or death did not result from act or omission of the Mare Owner. If the Mare miscarries, proves barren after being pregnancy-checked in foal, or fails to conceive during the normal breeding season, Mare Owner may rebreed Mare to Stallion in the immediately subsequent breeding season, so long as Mare Owner provides Stallion Manager with a statement from a licensed veterinarian to that effect. Any re-breeding of Mare to Stallion will be subject to payment of \$350.00 rebreed fee plus applicable shipping/or pickup charges. A mare owned by same Owner may be substituted upon approval of Stallion Owner. Mare Owner agrees that rebreed privileges shall be null and void if the Mare is bred to another stallion before returning to the Stallion. If the Mare Owner fails to rebreed the Mare the subsequent breeding season, then any and all fees become forfeited, the right to rebreed is cancelled and the Stallion Owner is released from all further obligation of this contract.

**COLOR FOAL GUARANTEE (CFG):** The Color guarantee will apply to APHA only registered mares. If the resulting foal is solid in color and not eligible for regular APHA registry as per current rules, the Mare may be rebred in the 2025 season only. The Mare is entitled for a rebreed at a discounted stallion fee of \$900.00 plus applicable shipping/or pickup charges. Any foal which is solid in color must be DNA tested to ensure that it is not eligible for registry under RG-070 in order to qualify for the color rebreed guarantee. A mare owned by same Owner may be substituted upon approval of Stallion Owner. If the Mare Owner fails to rebreed the Mare the subsequent breeding season, then any and all fees become forfeited, the right to rebreed is cancelled and the Stallion Owner is released from all further obligation of this contract.

The **LFG** and the **CFG** in this contract is non-transferable and non-assignable. Should the Mare be sold or otherwise disposed of prior to the birth of the foal, the LFG and CFG granted shall be void. However, the Stallion Owner may, at his /her discretion, upon application and payment of applicable fees, continue to honor the LFG/CFG granted to the original owner. In the event that the Stallion Manager agrees to the transfer or assignment of rights under the terms of this contract, then the new owner agrees to be bound by all terms and conditions hereof, insofar as the same may then be applicable.

**BREEDER'S CERTIFICATE:** Stallion Owner will require notification of breeding dates by November 1<sup>st</sup> of breeding year in order to submit a Stallion Breeding Report for your Mare. Upon notification of the birth of a live foal and after all fees and expenses have been paid, a Breeder's Certificate will be issued to the Mare Owner. Late notification of breeding dates may result in additional fees at Mare Owner's expense to be put on the Stallion Breeding Report.

**STALLION SUBSTITUTION:** If the stallion dies or becomes unfit for service during the breeding season and the Mare is not in foal, this Agreement shall become null and void. The Stallion Owner reserves the right to offer frozen semen to fulfill this contract and/or the option to breed to another True North Show Horses resident stallion. If the Mare dies or becomes unfit for breeding, a different mare may be substituted only upon agreement modification by both the Mare Owner and Stallion Owner.

**WARRANTY:** No warranties whatsoever, expressed or implied, shall accompany a breeding transferred by this Agreement. No guarantee of delivery of shipped semen within a certain time period or guarantee that shipped semen will safely reach the insemination point without losing some integrity, quality or characteristics is given by this Agreement.

**VENUE AND JURISDICTION:** This contract will be governed by the laws of the State of Texas. The parties hereby specifically agree that this Agreement shall be construed, governed and interpreted by and in accordance with the internal laws of the State of Texas. If any action or arbitration is brought to enforce or interpret the terms of this Agreement, the proper place of venue shall be Grayson County, Texas.

**ADDITIONAL PROVISIONS:**

1. Mare Owner agrees that nothing shall be posted or shared via social media or other means that could be negatively construed regarding the Stallion, True North Show Horses LLC, the Stallion Station, or any other affiliates. Failure to do so may result in legal action regarding the content and damages associated from such action. True North Show Horses LLC reserves the right to terminate this contract in such case. Any offending Mare Owner will, in such instance, immediately forfeit any rights to a breeding granted by this contract and this contract will terminate, with any outstanding balances owed by Mare Owner surviving termination.
2. This contract shall serve as the entire Agreement between Stallion Owner and Mare Owner, voiding any prior verbal or written agreements. Any additions to this agreement must be in writing and signed by both parties.
